The publication frequency of this journal is quarterly i.e every year four issues will be released. This strategy allows time for peer review, editorial processes, and content production while disseminating research findings, trends, and advances. The body of the text is required to be written in Times New Roman font size 12 on A4 paper with 1.15 spacing and has no word restriction. Generally, manuscripts are printed in black and white, however, authors can opt colored printed content subject to additional charges.

1. Introduction

The introduction should talk about the suggested research's past, present, and future. Explain what abbreviations and acronyms mean for the first time in the text. Authors are asked to include up-to-date sources that highlight the work's background. Additional sub headings such as separate aim, objective, literature review etc., not permitted.

2. Literature Review (Omit this section if not relevant)

A literature review should be presented in this section with appropriate citations.

The literature review critically examines and synthesizes existing research related to the study topic. Its purpose is to provide context, summarize the current state of knowledge, identify research gaps, and establish the theoretical foundation for the study. The following are essential elements to include in the literature review.

3. Experimental or Materials and Methods

3.1, Participants, Measures, Procedures, Analysis, Instruments and Software (Use numbering for each sub headings)

4. Results and Discussion

- 1) Include Figures, Tables, and equations and numbers in the text wherever necessary and provide proper explanations.
- 2) Subheadings are not compulsory.
- 3) Figures must have a resolution of 300 dpi
- 4) Equations must be editable (Use Microsoft or math type)
- 5) Units (SI units are highly encouraged)
- 6) Use Zero before any decimal point (Eg. 0.12)

5. Conclusion

- 1) Conclusion should summarize the key results, suggestions and applications of the paper and it should not resemble the abstract.
- 2) Do not include References
- 3) The conclusion must be between 250-350 words.

Acknowledgement

Acknowledge anyone who has contributed to the research (e.g., funding organizations, research assistants). There is need to write the entire names of the funding organizations. Additionally, any people that assisted with the study should be listed by the authors.

Funding Information

There should be a sentence like "The author(s) disclosed receipt of the following financial support for the research, authorship, and/or publication of this article: This work was supported by the Faculty of Psychology Council [grant number xxx]" in the manuscript of all research papers.

References

The reference is a list of reference / references is not a bibliography, thus, should contain all sources referred to in the manuscript; no need to contain unassigned sources. The reference list contains all references in the text derived from sources that are (a) relevant, (b) at least 80% are recent studies (last 10 years), and (c) at least 80% are primary studies, particularly from journal articles). The reference in *AJBRI* refers to the American Psychological Association (APA) 7th style to be followed.
